

M/s Indian Cane Power Limited, Uttur Village, Mudhol Taluk, Bagalkot District have obtained CFE Exp from the Board for expansion of sugar cane crushing capacity from 5000 TCD to 12000 TCD and Co-generation power plant from 28 MW to 72 MW vide Ref (2) The industry has filed CFO application for expanded capacity of sugar cane crushing and Co-generation power plant at Regional Office, Bagalkot on 11.06.2015. The Regional Officer has forwarded the CFO application filed by the industry along with his report to Board office. The subject was deliberated in the Consent Committee Meeting held on 29.07.2015. The committee recommended for issue of CFO for expanded capacity under the Water & the Air Acts for the period up to 30.06.2016 with conditions subject to compliance to CPCB directions regarding on-line monitoring. The R O Bagalkot inspected the industry on 08.09.2015 and reported that the industry has installed the online monitoring system to the ETP at polishing pond.

Consent is hereby granted under section 25 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 (herein after referred as the Water Act and the Air Act respectively) and the Rules and Orders made there under.

Consent is granted to 'The Managing Director, M/s Indian Cane Power Limited, Uttur Village, Mudhol Taluk, Bagalkot District' authorizing him to operate the industrial plant at the above said premises and to make discharge of effluents and emissions from the premises as mentioned above, subject to the terms and conditions as detailed in the schedule annexed to this order.
