## CORRIGENDUM TO CONSENT ORDER

Ref: 1. Combined Consent Order No: PCB/139/HPI/2015/1676 dt:14/12/2015

2. Industry letter dt. 12/01/2016

Board has issued the Combined Consent for operation under the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981 to The Managing Director, M/s Indian Cane Power Limited, Uttur-587313, Mudhol Taluk, Bagalkot District for sugarcane crushing of capacity 12000 TCD and co-generation of 72 MW with validity upto 30/06/2016.

Industry vide letter dt: 12/01/2016 expressed that the consent issued vide Ref(1) needs to be corrected with respect to Co-generation power plant capacity from 72 MW to 78 MW and in respect of solid waste generation viz., Press mud generation from 200 TPD to 480 TPD and Ash from 15.55 TPD to 37.32 TPD. On verification of the consent application filed by the industry for seeking consent for the period 2015-16, it is requested for Sugar cane crushing 12,000 TCD and Cogeneration unit for 78 MW. In this regard, the industry has obtained environmental clearance from SLEIAA vide letter No: SEIAA 16 IND 2014 dt: 08/12/2014 for Sugarcane crushing 12,000 TCD and Co-generation power plant of capacity 78 MW. Board has also issued CFE vide letter No: PCB/139/HPI/2014/1426 dt: 05/01/2015 for sugarcane crushing of capacity 12,000 TCD and Co-generation power plant of capacity 78 MW. In view of the above, and on examining the records, the following corrigendum to the Consent for Operation order issued under Water and Air Acts is issued as under.

## ORDER

The combined Consent for operation order issued vide consent Order No: PCB/139/HPI/2015/1676 dt:14/12/2015 to the Managing Director, M/s Indian Cane Power Limited, Uttur-587313, Mudhol Taluk, Bagalkot District for sugarcane crushing of capacity 12000 TCD and co-generation of 72 MW shall be read as Sugarcane crushing of capacity 12,000 TCD and Co-generation power plant of capacity 78 MW.

In respect of Solid waste management as indicated in Sl.No.IX of the terms and conditions enclosed alsong with the combined Consent for operation order dt: 14/12/2015, the quantity of solid waste and mode of disposal shall be replaced with the following table;

1.	Press mud	480	Mixed with ash and sold to farmers as manure
2.	Ash (bottom & fly ash)	37.32	Mixed with press mud and sold to farmers and also sold to brick manufacturers
