AUTHORIZATION FOR HANDLING HAZARDOUS WASTE

1. The Chief Executive Officer of M/s. Indian Cane Power Limited, Uttur, Mudhol, Bagalkot - 587 313, is hereby granted an authorization under Rule 5(4) of Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008 as amended upto 2010 for **handling Hazardous Waste** in the manner indicated below while carrying on the activity of sugarcane crushing of capacity 5000 TCD and 28 MW Co-generation.

Waste Category	Hazardous Waste generated	Quantity	Method of Handling
5.1	Used Oil	0.5 KL/A	Shall be collected in leak proof containers & disposed only to KSPCB registered, authorized re-processors provided the oil meets the standards as per Schedule - 5 Part-A of the Rules.
5.2	a) Oil soaked cotton waste b) oil & diesel filters	0.01 MT/A 5 No's/A	Shall be stored in a secured manner and handed over to KSPCB authorized Incinerator/Co-Process in cement kiln.

2. This authorization is issued with reference to the application dated: 20.05.2013 and will be in force for a period from **01.07.2013 to 30.06.2018** unless cancelled or suspended. ("Consent Conditions shall be referred along with Conditions of this authorization").
3. The authorization is subjected to the conditions stated below and such conditions as may be specified in the Rules for the time being in force under the Environment (Protection) Act, 1986.


TERMS & CONDITIONS OF AUTHORIZATION

1. The person authorized shall comply with the provisions of the Environment (Protection) Act, 1986 and the Rules made there under as well as Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008 as amended from time to time.

2. This authorization or its renewal shall be produced for inspection at the request of an Officer authorized by the Karnataka State Pollution Control Board.
3. The person authorized shall not rent, lend, sell, transfer or otherwise transport the hazardous wastes without obtaining prior permission of the Karnataka State Pollution Control Board.
4. Any unauthorized change in personnel, equipment or working conditions as mentioned in the application by the person authorized shall constitute a breach of this authorization.
5. It is the duty of the authorized person to take prior permission of the Karnataka State Pollution Control Board to close down the facility.
6. An application for the renewal of an authorization shall be made 60 days before the date of expiry.
7. The Person authorized shall bring to the notice of the Board any increase in quantity, change in category, handling operation and obtain fresh authorization.
8. Karnataka State Pollution Control Board reserves the right to review, impose additional condition or conditions, revoke, change or alter the terms and conditions of this authorization or to suspend or cancel this authorization.
9. The Person authorized shall take steps for reduction and prevention of the waste generated or for recycling or reuse.
10. The person authorized shall maintain the records at site in Form-3 and shall submit the details in Form-4 within 30th June every year for the Period April to March. And Form-13 for manifest.
11. The person authorized shall store the hazardous waste in a closed shed with impervious floor. The hazardous waste shall be packaged and labeled based on the composition. The labeling and packaging shall be easily visible and be able to withstand physical conditions and climatic factors.
12. The transportation of hazardous waste shall have to be carried out only through registered/authorized vehicles meant for transportation of hazardous waste.
13. The person authorized shall store the incinerable hazardous waste as per CPCB Guidelines (website www.cpcb.nic.in) published on Nov. 2008 to avoid any fire accident.
14. The person authorized shall display the online data with regard to details of hazardous waste (generation, storage and disposal), solid waste (generation, storage & disposal), Water Act and Air Act details in the Board measuring minimum size of 6' x 4' (refer website <http://kspcb.gov.in>)
15. The Person Authorized shall not store the Hazardous Waste more than ninety days as per Rule 7 (1).
16. **Display Boards**
The person authorized shall display sign boards at the storage site as "Hazardous Waste Storage site" and "Danger" and the site shall be provided with accident preventive measures.
